The PSUs were granted to the Reporting Person for no consideration on June 4, 2008. On January 13, 2011, the closing price of the Issuer's Class B common stock on the New York Stock Exchange was \$41.27 per share.
- Represents shares withheld pursuant to the terms of the Viacom Inc. 2006 Long-Term Management Incentive Plan, as amended and restated January 1, 2011 (the "LTMIIP"), to satisfy tax liability incident to the vesting of, and delivery of shares underlying, the PSUs.
