Represents the minimum number of shares to be received of an aggregate target grant of 1,000,000 Performance Restricted Share Units ("PRSUs"), which will vest in four equal annual installments beginning on September 30, 2011 and be settled by delivery of a corresponding number of shares of the Issuer's Class B common stock upon vesting. Depending on achievement of performance conditions during the four performance periods, the number of shares ultimately received upon vesting will range from the minimum of 75% to a maximum of 125% of the aggregate target grant.
- 3. The Stock Options will vest in four equal annual installments beginning on April 20, 2011.
