- These shares were issued on May 18, 2018 upon vesting of the first of four equal annual installments of RSUs that were granted on May 18, 2017. On the date of vesting, the closing price of the Class B Common Stock on The NASDAQ Global Select Market was \$27.24 per share.
- These shares were issued on May 20, 2018 upon vesting of the third of four equal annual installments of RSUs that were granted on May 20, 2015. On the date of vesting, the most recent closing price of the Class B Common Stock on The NASDAQ Global Select Market was \$27.24 per share.
- Granted under the Viacom Inc. 2016 Long-Term Management Incentive Plan for no consideration.
- Granted under the Viacom Inc. 2006 Long-Term Management Incentive Plan, as amended and restated as of January 1, 2011, for no consideration.
