Explanation of Responses:

- The shares identified in Table I were issued on November 30, 2020 upon vesting of the second of four equal annual installments of the Restricted Share Units ("RSUs") identified in Table II, which were initially granted on November 30, 2018. On November 30, 2020, the closing price of the Class B common stock on The NASDAQ Global Select Market was \$35.28 per share.
- These shares were withheld by ViacomCBS to satisfy tax liability incident to the vesting of, and delivery of shares underlying, the RSUs, and were not actually sold or otherwise disposed of in an open-market transaction.
- Granted under ViacomCBS's long-term incentive plan for no consideration.
- These RSUs will vest in four equal annual installments beginning on November 30, 2021 and a corresponding number of shares of Class B common stock, net of any shares withheld by ViacomCBS to satisfy tax liability incident to the vesting of the RSUs, will be delivered on each vest date.
