(CBSBI), which in turn is a wholly-owned subsidiary of Westinghouse CBS Holding Company (WCBSHC), which is a direct wholly owned subsidiary of CBS Corporation (CBS), but may also be deemed to be beneficially owned by (1) CBSRI, (2) CBSBI, (3) WCBSHC, (4) CBS and (5) National Amusements Inc.(NAI), which beneficially owns approximately 79.6% of CBS Corporation's voting stock, and (6) Summer M. Redstone, who is the controlling stockholder of NAI. Mr. Redstone disclaims beneficial ownership of these securities except to the extent of his pecuniary interest.
